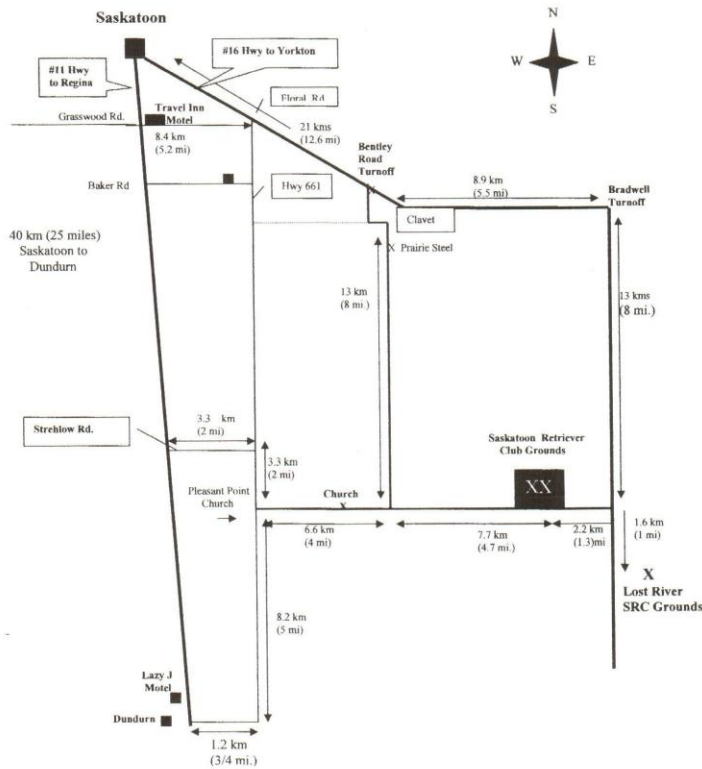

- ◆ **Entries close June 14 (Mon) 7:00 p.m. for tests on June 19, 2010.**
- ◆ **Entries close June 19 at 7:00 p.m. for tests on June 20, 2010.**
- ◆ Cheques payable to the Saskatoon Retriever Club (Canadian Funds). Dated no later than the closing date. Mail early. **NO PHONE OR FAX ENTRIES WILL BE ACCEPTED.**
- ◆ Mail cheques and completed entries to: Sharon Ball, Test Secretary, Box 291, Asquith, Sk., S0K 0J0, Ph. (306) 329-4266. A separate entry form for EACH DOG in EACH STAKE is required.
- ◆ All entries must be accompanied by the full entry fee (and listing fee of \$8.56 if applicable). A listing fee per dog per event is payable unless the dog's entry carries a CKC individual registration number or ERN number.
- ◆ All **Non CKC members** must submit a \$3.00 per dog/per entry(day) fee.
- ◆ Running order will be determined by a draw. Multiple entries by the same owner/handler will be automatically separated unless otherwise requested.
- ◆ Pigeons, ducks or pheasants may be used on land and ducks will be used in the water.
- ◆ Standard CKC Rosettes to all dogs qualifying in each event.

### SCRATCHES

Scratches will forfeit \$10.00 per entry. "No Show Refund" requests must be made in writing to the Test Secretary within 14 days of the event, explaining the reasons for the scratch.
